#### Introduction


#### **Transient Occupancy Tax Data**

An analysis of the Santa Maria Valley Transient Occupancy Tax (TOT) shows a year-to-date decrease of -5.25% in 2024 compared to 2023. The monthly totals for 2024 show a mix of declines and gains when compared to 2023.

For July and August 2024, Transient Occupancy Tax (TOT) collections totaled \$453,920.91 and \$363,851.23, respectively. July saw an 8.37% increase over 2023, while August had a 5.65% decrease. The year-to-date total stands at \$2,592,976.82, a 5.3% decrease from the same period in 2023. These figures indicate steady but varied performance across summer months, with an overall YTD decline.

#### Workforce Development Board Partnership

The Chamber presented an update on their two business outreach contracts at the Workforce Development Board's annual meetings. Over 40 businesses have signed up for the first information session on the paid work experience program for justice-involved individuals, which will be held early November.



#### **Teacher Tours**

Our October Teacher tour focused on "Green Construction." We toured the Santa Maria Carpenters Training Center, a local housing development in construction with Coastal Community Builders, and Engel & Gray's composting site. Teacher tours are held monthly in partnership with the Santa Barbara County Education Office. The tours connect local high school CTE teachers with industry professionals, so they can take information about local jobs and skills needed back to their students in the classroom.



#### Leadership Santa Maria Valley

On October 4th the LSMV class had the Agriculture topic day. They toured Driscoll's and learned about the berry industry. They also toured Nutrien Ag Solutions and Plantel. On October 23rd LSMV held an Alumni Lunch & Learn. There were 14 in attendance and the featured speaker was retired Fire Chief Leonard Champion.



#### Advocacy

- The Chamber partnered with the League of Women Voters on Candidate Forums for the City of Santa Mayor, and the Santa Maria Airport Board. A combined total of over 80 individuals attended the forums. (A candidate forum for City Council was held in September.)
